Thus the maximum price fixing itself is an act 'in restraint of trade' within the language of the Clayton Act. This is so although the selling price was raised only by approximately 4%. In *United States v. Socony-Vacuum Oil Co.*, supra, 310 U.S. at page 221, 60 S.Ct. 811, 84 L.Ed. 1116, the Supreme Court was at pains to establish the right of a defendant to keep records of his prices for the purpose of proving that he had met them in a bona fide competitive market. Those records were admissible in evidence. Nothing like that occurred here. The economists were not permitted to prove the actual price or quantity of the various drugs they had purchased, as they did in *United States v. Socony-Vacuum Oil Co.*, supra, but they were permitted to testify as to what they had bought the drugs for and the expert opinion of their value. 11 Furthermore the economic experts were all called by the Government. This suggests that the purpose of the indictment was to aid in the prosecution of the case as soon as a conspiracy was proved. See *United States v. Loewe*, supra, and *United States v. Socony-Vacuum Oil Co.*, supra. If it had been expected to demonstrate an existing conspiracy the Government would not have called so many witnesses. Each expert was a paid Government employee, whether he was testifying on behalf of the United States or for the defendants. The defendants had no access to the

The aim of the present study was to investigate the biocompatibility of microspheres bearing poly(hydroxyethyl methacrylate) (PHEMA) modified by 7-ethyl-10-hydroxy-camptothecin (SN-38) or

oxaliplatin (L-OHP), and to examine the influence of poly(ethylene glycol) (PEG) copolymer on the cellular response to PHEMA microspheres. Murine macrophage-like cell line, RAW264.7 cells, were cultured in media containing various concentrations of PHEMA microspheres. The

microspheres were labeled with phycoerythrin and then the microspheres were incubated with RAW264.7 cells at a seeding density of 1×10^6 cells/well. Cellular viability, cellular attachment, detachment, death rate and proliferation rate were determined. A 5% PEG copolymer coating on the

PHEMA microspheres enhanced cellular adhesion, viability, and proliferation in a dose-dependent manner compared to uncoated microspheres. L-OHP-capped PHEMA microspheres exhibited enhanced cytotoxicity against RAW264.7 cells compared to SN-38-capped microspheres. A 5% PEG co-

polymer coating on the PHEMA microspheres greatly enhanced the cytotoxicity of PHEMA microspheres against RAW264.7 cells. An appropriate capping group is a key for the functionalization of PHEMA microspheres. The St. Louis Metro police department has officially identified the suspect arrested in connection
