As the ACLU of Utah's lawsuit argues, the USCA violates the First and Fourth Amendments. If the government were to obtain such real-time electronic data to identify an e-mail address where evidence of a crime might be found — let's say, a murder suspect's e-mail account — the USCA would require the government to install a wiretap with a mini-jack attached to the computer, which would be

forcibly plugged into the suspect's computer. This would violate the Fourth Amendment. Because wiretapping requires a warrant, the USCA requires the government to obtain a warrant from the state's telephone and email wiretap court every time it seeks real-time electronic information without reasonable suspicion. In addition, the USCA requires the government to "itemize" the information sought. As a result, the USCA would require the government to write to the court every time it wants to install a wiretap, even for the most limited inquiry. Our motion argues that the USCA, and the technical specification of the Utah wiretap court, "are unconstitutional precisely because they permit the government to use private citizens' computers and networks to perform the tracking without individualized suspicion." The USCA also permits the government to install surveillance equipment that can listen for both live communications and previously-stored data, a violation of the Fourth Amendment. State wiretap laws are just as unconstitutional as federal wiretap laws. Yet the ACLU of Utah is limited to challenging one

statute on privacy grounds. We need all federal and state wiretap laws invalidated. If the government were to install the US f988f36e3a
